The Connection Between Your Commute and Climate Change

By now, you have surely seen your fair share of media coverage on the Climate Change issue. Whether you agree that we humans are the cause, or that its solely a natural occurring scientific phenomenon remains debated, though it seems somewhat less these days. And regardless, the movement is already underway with 'going green' in every possible facet of life. Certainly going green is inclusive of ridesharing. One thing hasn't changed, however, and that is what rideshare programs like

ours and those throughout the world have been actively advocating to commuters and businesses for many years; sharing the ride makes a difference. Among traditional program messaging to the public touting the benefits of ridesharing so we can improve air quality, re-

duce congestion and save ourselves some almighty bucks while we're at it, the true value of these simple actions has become even more evident—sharing the ride, or cutting vehicle miles traveled can have a positive impact on global warming.

Across the globe, solutions such as increasing fuel efficiency, decreasing carbon intensity of fuels, and reducing vehicle miles traveled are taking center stage to try to address the situation. A recent re-

port within the transportation industry focused on this very subject. What stood out as an important fact as it relates to the first two solutions— increased fuel efficiency and decreased carbon intensity— is that these strategies do not address congestion and public health in their effectiveness, whereas reducing vehicle miles traveled (something that occurs with every rideshare trip taken) does. So, given the opportunity to really make a difference, commuting in a carpool, van-

pool, on public transit and especially biking and walking your way to work will provide the single most significant benefit all the way around.

We want to thank all of you who dedicate yourselves to your rideshare arrangement. In the coming months, we hope you will support our ef-

forts to increase the number of ridesharing individuals throughout the state. How can you do this? Simply tell a friend about our service. Federal Tax Benefits.. Is Your Employer On Board?

Federal tax benefits are available through use of employer-offered IRS Section 132(f) Qualified Transportation Benefits. These benefits provide a tax benefit to employers, and employees save too! Employers can offer them in one of the following ways:

- Employer-Paid Transportation Benefits. Employers can pay for their employees to commute by transit or vanpool, up to a limit of \$115/month. With this arrangement, employees get up to \$115 in a tax-free transportation benefit. Employers get a tax deduction for the expense and enjoy savings on payroll-related taxes. Employers have found that providing transportation benefits offers significant savings over offering the equivalent dollar value to employees in the form of a salary increase.
- Employee-Paid, Pre-Tax Transportation Benefits. Employers can allow employees to set aside up to \$115/month of pre-tax income to pay for transit or vanpooling. Employers save money overall since the amount set aside is not subject to payroll taxes. Employees save money, too, since the amount of an employee's salary set aside for transportation benefits is not subject to income tax, up to the specified monthly limits.
- Shared-Cost Transportation Benefits. Employers can share the cost of transit or vanpool costs with employeesand everyone can receive valuable tax savings. With this approach, employers can provide a portion of the cost of taking transit or vanpooling as a tax-free benefit and allow the employee to set aside pre-tax income to pay for the remaining amount of the benefit (up to the specified limits).
- Parking Cash-Out. Employers can offer their employees the option to "cash out" of their existing parking space. For example, if Company A subsidizes parking for their employees at \$60/month, a parking cash-out program would allow employees to choose from the following options: (1) keep the parking space worth \$60/month, (2) give up the parking space and receive \$60 extra each month in taxable salary, or (3) receive \$60/month in tax-free transportation benefits to pay for transit or vanpooling. Cash-out programs often work best for employers that pay separately for parking and for organizations with parking shortages or plans to expand parking facilities.

<u>www.ridesharedelaware.org</u> Upgrade Shows Increased Activity

Since our updated website launched in mid-October, we've been seeing a steady increase in web activity as well as monitoring the results of our on-line surveys.

Web Activity— Visits to the site have nearly doubled in the past several months while the total hits has just about tripled. And, while most visitors do not accept cookies (meaning we can't track their frequency to our site), of those who do, half are new visitors and the other half are returning visitors.



Entry Pages—The top five landing pages are the home page (67.80%), the online application (6.68%), our Promotions page (4.39%), the Public Transit page (2.07%), and our Calendar of Events page (1.75%).

And the on-line Survey says...

• Based on feedback from our program participants alone, 55% or more rate our new look 'very well done' as it

relates to content, ease of navigation and overall design.

- 67% have referred our program to others.
- Combined, 90% indicate that they plan to or may be frequent visitors to our site to obtain program information.
- Survey takers not yet registered with the program rate the Cost of Commuting and Personal Vehicle Wear and Tear as the top two factors for considering use of non-drive alone commute methods.
- Most, 56%, think that Employers have the biggest influence on encouraging use of non-drive alone commute modes followed by the Government at 39%.
- 42% cite the DART First State/DelDOT websites as their primary transportation information resource followed by the internet and then radio.

DART's RideShare Delaware has been serving Delaware employees with their commute needs since 1997. Funded with a combination of Federal Congestion, Mitigation & Air Quality (CMAQ) and State dollars, the goal of the program is to reduce the number of single occupant vehicles (SOVs) traveling on Delaware's roadways, thus improving our Air Quality. RideShare works in partnership with local and regional agencies towards meeting Federal Air Quality Standards. The RideShare program is operated under DART First State, Delaware's transit agency, and offers free ridematching services for commuters working in Delaware as well as free assistance to Delaware employers interested in establishing employee commuter benefits programs. RideShare also offers an emergency ride home benefit for registered commuters actively ridesharing to work; vanpool services; and, free carpool matching for parents of Delaware school students. RideShare Delaware is administered by Parsons, Brinckerhoff and the office is located in downtown Wilmington, Delaware. RideShare's programs and services cover the entire State of Delaware.
